General Waiver Form

The Sheridan KidsLife staff and volunteers welcome you to our facility and activities. We are thankful that you are here to participate in a Sheridan KidsLife event. Please be advised, that if you sustain injuries while participating in any of the KidsLife activities you will assume any and all financial responsibility, as well as the filing of all medical claims with your individual health carrier. In consideration of choosing to participate in any of the KidsLife activities the undersigned, acknowledge, appreciate and agree that:

1) Injury Risk *

The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and

2) Assuming Risk *

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,

3) Comply with Conditions *

I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest staff or volunteer immediately; and, I further agree to abide by all safety rules adopted by the Organization, and will utilize all safety devices where provided. If I do not understand the procedures at KidsLife, I will ask for assistance of trained KidsLife Staff Prior to conducting the activity.



4) Negligence *

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS SHERIDAN KIDSLIFE, their directors, officers, officials, agents, volunteers and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable,

owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

5) Photo Release *

I hereby grant SHERIDAN KIDSLIFE permission to use my likeness and my child's likeness in a photograph, video, or other digital media ("photo") in any and all of its publications, including web-based publications, without payment or other consideration.

Conduct Agreement *

Practice good citizenship, leadership, and have a positive attitude at all times

Be honest and trustworthy in my participation at the Klubhaus

Show respect to others (peers and adults) by being courteous and respectful

I will not bully, intimidate, put others down or be disrespectful in any way to SKL staff, volunteers, peers, and parents of other students

Use appropriate language: I will not swear or use insulting, vulgar or offensive language

Maintain acceptable noise levels inside and around the entire Klubhaus and surrounding property

Will not play music, videos or look at photos with offensive, vulgar, suggestive, and unacceptable language or content on my phone or any device while participating in SKL activities

Be free from possession and consumption of drugs, alcohol, and/or tobacco

Leave all bikes and skateboards/ longboards in their designated area

Refrain from possession of a weapon of any kind including pocket knives and any fire arms

Abide by the Klubhaus hands off policy. I will not partake in sexual or dangerous behavior in or around the Klubhaus, including kissing, extended hugging, cuddling, inappropriate touching, wrestling, and hitting.

Be respectful of SKL Klubhaus property, no intentional destruction of property or graffiti

Be respectful of others' property and not steal, borrow, damage, or hide anything that isn't mine

Clean up after myself and help staff clean up when directed to do so

Report any and all problems or issues to the staff on duty

Respect and adhere to the guidelines of the Youth Parent Handbook

Accept the consequences for inappropriate behavior including removal from the Klubhaus for the day, contact with my parents/ guardians, suspension from the Klubhaus for multiple days, permanent dismissal from SKL programs
